SECTION II: OBJET DU MARCH

Intitul attribu au march: Awarding of two licenses for providing ground handling services (cargo) at Luxembourg Airport

Description succincte du march : The scope for the provision of third-party ground handling services in the field of cargo activities at Luxembourg Airport under the licenses to be awarded by the Ministry of Mobility and Public works based on the outcome of this tender, includes the following:

- a) Services pursuant to section 4 of the Annex according to the council directive 96/67/EC transposed into national law by the Luxembourgish law dated 19th May 1999: Freight and mail handling as far as the specific carriage of freight and mail between the airport and the aircraft on arrival, departure or transit is concerned.
- b) Services according to section 5.1 5.7 of the Annex according to the council directive 96/67/EC transposed into national law by the Luxembourgish law dated 19th May 1999:

Marshalling the aircraft on the ground at arrival and departure

Assistance to aircraft parking and provision of suitable devices

Communication between the aircraft and the airside supplier of services

The loading and unloading of the aircraft including the provision and operation of suitable means, as well as the transport of crew between the aircraft and the terminal

The provision and operation of appropriate units for engine starting

The moving of the aircraft at arrival and departure, as well as the provision and operation of suitable devices

The transport, loading on to and unloading of from the aircraft of food and beverages

c) Services according to section 6.1 6.3 of the Annex according to council directive 96/67/EC:

The toilet and water services

The cooling and heating of the cabin, the removal of snow and ice, the de-icing of the aircraft

The rearrangement of the cabin with suitable cabin equipment and the storage of this equipment

SECTION IV: PROCDURE

Conditions d'obtention du cahier des charges :

The RFQ documents for the submission of the applications shall be downloaded from the Luxembourgish public procurement portal by searching for the above-mentioned tender on their official site (https://pmp.b2g.etat.lu/) in accordance with the Luxembourg law dated April 8 2018, on public procurements.

SECTION VI: RENSEIGNEMENTS COMPLMENTAIRES

Autres informations:

The service provider must provide all the services listed above in their entirety (bundles), as this bundling is operationally necessary and required for the most efficient use of the available space and handling capacities. Applications that only cover part of the services are not admissible and will be excluded.

The provision of these ground handling services at lux-Airport is limited to two service providers in accordance with the applicable law. The objective of the present selection procedure is therefore the approval of two service providers.

Please note that in accordance with articles 7 and 12 of the law dated 19th May 1999, the existing Cargo Center at Luxembourg Airport falls under Installations and facilities other than centralized infrastructures, subject to separate lease contracts to be negotiated and entered into with lux-Airport. Operating the Cargo Center and activities within the Cargo Center fall outside of the scope of this tender.

Please note that aside from third party cargo handling licenses granted to ground handlers, some local airlines are also granted cargo self-handling licenses at Luxembourg Airport in accordance with the law dated 19th May 1999. More information will be given in the request for proposal documentation.

Conditions de participation : The Exclusion grounds and Minimum Requirements for application are specified in the RFQ document.
