SECTION II: OBJET DU MARCHÉ

Intitulé attribué au marché : Instruments for analysis of chemical warfare agents

Description succincte du marché : National and international threats led the national government to decide on the implementation of a laboratory having the mission to be able to detect biological and chemical warfare agents using state of the art analytical systems. The new laboratory will be installed and maintained at the "Laboratoire national de santé" (LNS) in Dudelange.

The present public tender covers the chemical systems to be acquired for the new laboratory. It includes 3 independent lots described in Appendix B_1a, B_1b, B_1c, B_2, and B_3:

- Lot 1 - Parcel A : Gas chromatography equipped with a single quadrupole mass detector with electron impact and chemical ionization capabilities (GC-MS with EI/CI modes),
- Lot 1 - Parcel B : Liquid chromatography system allowing direct injection and on-line SPE connected to a triple quadrupole (LC-MS/MS with ESI mode, on-line SPE),
- Lot 1 - Parcel C : Gas chromatography equipped with a single quadrupole mass detector (electron impact ionization) and an "all in one" multifunctional autosampler allowing standard liquid introduction, headspace, SPME, automated thermal desorption and thermal extraction (GC-MS with EI mode, HS, SPME, TD),
- Lot 2 : Raman Spectrometer (handheld),
- Lot 3 : Flame Spectrometer (handheld).

Lot 1 :3 MS

- Description succincte : lot including 3 parcels for the 3 MS systems (GC-MS with EI/CI modes, LC-MS/MS with ESI mode and on-line SPE, and GC-MS with EI mode, HS, SPME, TD)

Lot 2 :Raman Spectrometer

- Description succincte : Raman Spectrometer (handheld)

Lot 3 :Flame Spectrometer

- Description succincte : Flame Spectrometer (handheld)
