Conditions de participation : The Bidder is required to demonstrate corporate experience, technical capability, and financial means to support the implementation and operation of the VLT infrastructure of the Loterie Nationale. The Bidder shall describe, in detail, at least 1 of its current and historical experience with lottery VLT systems and/or services; that is, descriptions and references of gaming industry engagements of comparable complexity and sensitivity that have been conducted by the Bidder over the past five (5) years. The Lottery is certified according to the WLA Security Control Standard and the related ISO 27001 standard. The Bidder must be certified in accordance to ISO27001 and the Contractor must be prepared to achieve WLA Security Control Standard certification.
